Marianne Ramsay Sonneck, Dr. Anbelang and Mathias Lenz greet the visitors and present the evening's program and the two constitutional claims. Silke Lange improvises to the datasheets of the Early Mining Bee, the bacterium *Hypomicrobium vulgare* and the Maple mildew, as well as to scores of Florian Japp.

The visitors who take on the function of the jury, inform themselves in conversations on the carpet with the parliamentarians present, take a look at the State Archives, listen to the soundtracks with relevant sections of the parliamentary discussions and also the first fragment of the audio drama by David Lindemann.

Public hearing

The complaints are again read out briefly and Marianne Ramsay-Sonneck as Ombudswoman represents the position of the plaintiffs and Georg Reinhardt as prosecutor that of the legislature and the executive.

A compromise settlement in relation to the complaint "Cleanliness is deadly" of the Rotund Disk Snail and the group of mollusks and worms is introduced by Marianne Ramsay Sonneck, discussed by all participants, but not supported by the jury, so both lawsuits come to the vote. Silke Lange improvises on the base of the data sheets of Ground Elder and Rotund Disk Snail.

Judgment by Vote

Guided by the Allegory of Organisms Republic, the jurors vote on both complaints.

Complaint 1 "Discrimination claim" is accepted

Vote:

Yes, the group of herbs / grasses / perennials has been systematically disadvantaged and damaged and therefore there is a claim to protection and compensation measures.

Complaint 2 "Cleanliness is deadly" is rejected

Vote:

No, the removal of the so-called garbage in the sense of the Constitution and ADO does not constitute an illegal measure damaging the plaintiff and can therefore be continued.
